Directions:

- I-81 to Toms Brook Exit (Exit#291)
- Turn right at end of ramp onto Mt. Olive Road(Rt. 651) going west for one mile
- Turn left onto Rt. 623 (Back Road) going south.
- Go approximately 6 miles to Rt. 681 (Alonzaville Road) on the right.
- Alonzaville Road is a gravel road and very narrow road - go slow please and watch for oncoming traffic for just .5 mile. As the gravel road makes a sharp left, Walnut Hill Farm is straight ahead.

GUEST RIDER'S and/or MEMBER'S WAIVER OF CLAIMS AND COVENANT NOT TO SUE

This agreement is entered into as a condition of registration in the Crystal Crown Series Judged Trail Ride held by the Shenandoah Trail Riding and Horseman's Association, Inc (STRHA) and participation in its activities on September 9, 2007. I understand and acknowledge that any involvement with horses can be hazardous and that riding involves numerous risks of injury and that horses are often unpredictable and difficult to control. I knowingly and voluntarily assume all risks and dangers of such involvement. I agree not to sue STRHA or its officers, directors, agents or employees, the owners of Walnut Hill Farm, Maurertown, Virginia, or any landholders who have given permission to STRHA and its members to ride over their property during this event, including, but not limited to any claims alleging negligence, breach of contract, strict liability or otherwise of STRHA, the owners of Walnut Hill Farm, Maurertown, Virginia, or any such landholders. This covenant not to sue, waiver, and release includes but is not limited to bodily injury, death, property damage, loss, contribution, indemnity or any other claims which I may ever have against STRHA, the owners of Walnut Hill Farm, Maurertown, Virginia, or any such landholders. This agreement shall be binding upon the undersigned, and if applicable, any of their minor children who shall participate in this STRHA event.
